

# Data sharing agreement between Wycliffe Netherlands and Moorlands College

<b>1.</b>	<p><b>Between: Wycliffe Netherlands (abbreviated to Wycliffe) and Moorlands College (abbreviated to Moorlands)</b></p> <p>This agreement in no way supersedes or overrides any provisions in any other agreements entered into by both parties.</p> <p>Moorlands College is a charitable company registered at Companies House with company number 4241702 and registered with the Charity Commission for England and Wales with charity number 1092000. Moorlands is registered with the Information Commissioner’s Office (ICO) with registration number Z6065769.</p> <p>Wycliffe Netherlands is a charity registered in the Netherlands registered with the Chambre of Commers 40482863. WBN is registered with the Dutch Government with registration number 8048.55.110.</p>
<b>2.</b>	<p><b>Purpose and objectives of the information sharing</b></p> <p>The School of Language and Scripture ('SLS') at Moorlands is one of Wycliffe’s primary training institution for its potential fieldworkers. It is considered to be in the interests of individuals that information be shared between Moorlands College and Wycliffe in the following cases:</p> <ol style="list-style-type: none"><li>1. Information pertaining to prospective SLS students of Moorlands, and potential fieldworkers of Wycliffe. This is to ensure, for example, that the right advice and information is given to these potential applicants.</li><li>2. Information pertaining to current SLS students of Moorlands who are also current or potential fieldworkers of Wycliffe, and current fieldworkers of Wycliffe who are also current or potential students at Moorlands. This is to ensure, for example, that both institutions fulfil their duties of care to their students / fieldworkers.</li></ol> <p>In each case, the information is shared due to the fact that the School of Language and Scripture (known as SLS) at Moorlands functions as Wycliffe’s training institution. The relevant individuals thus relate to staff at both institutions with regard to decisions about overseas placements, pastoral needs, and study decisions. By sharing relevant personal data between staff at Moorlands and Wycliffe, students, fieldworkers and applicants receive the best possible advice in all the above domains.</p> <ol style="list-style-type: none"><li>3. Information pertaining to Wycliffe fieldworkers who are seconded to the staff of Moorlands. This is to enable Moorlands to exercise day to day oversight of the seconded staff.</li></ol>

4.	<p><b>Processor/s</b></p> <p>Data may be processed on the following systems, by organisations as specified below, in line with respective Data Protection Policies:</p> <p>Wycliffe: Google Drive, Workday, Microsoft Dynamics (Engage/CRM), DonorHub, Sharepoint/Onedrive.</p> <p>Moorlands: OneDrive, FileMaker, JotForm, iHasco</p> <p>Data processors will include Wycliffe staff, and Moorlands staff, acting on behalf of the Data Controllers, in accordance with both organisations Data Protection Policies.</p> <p>Moorlands College and Wycliffe remain Data Controllers for all processing activities covered in this document, under their own data responsibilities.</p> <p>Processing will be conducted in accordance with relevant Articles in the UK GDPR,<sup>1</sup> and the EU GDPR.<sup>2</sup></p>



The right to be informed</li> <li>2. The right of access</li> <li>3. The right to rectification</li> <li>4. The right to erasure</li> <li>5. The right to restrict processing</li> <li>6. 	<p>Wycliffe will discuss the data subject's concerns with the data subject, and seek to resolve the matter to their satisfaction as quickly as possible, and in line with the working practices of the Data Controller and respective Data Protection and Privacy Policies.</p> <p>Moorlands College will review complaints and requests in line with our Data Protection Policy, Student T's &amp; C's, SAR Policy and Retention Schedules. We will work to respond to the data subject and reach a suitable conclusion in line with our policies.</p> <p>Each party shall keep the other informed if a situation like this arises.</p>
<b>9</b>	<p><b>Transparency</b></p> <p>Both controllers must inform data subjects of their intention to share data with the other organisation.</p>
<b>10</b>	<p><b>How the data sharing will be carried out</b></p> <ol style="list-style-type: none"> <li>1. Data sharing will be carried out on a case-by-case basis only, as necessary. Mass-processing and automation will not take place.</li> <li>2. Often this data sharing will take place in conversation. Where data sharing occurs in writing, secure mail servers belonging to both organisations will be used in line with each organisation's existing data protection policy. Each organisation will be responsible for ensuring the security of data handled by their respective staff.</li> <li>3. This is likely to pertain to fewer than 30 individuals in any given year, so sharing of this nature rather than in a systematic manner is proportionate in light of the low numbers involved.</li> <li>4. No data will be processed outside the UK or the Netherlands, including sharing between the data controllers.</li> </ol>
<b>11</b>	<p><b>Accuracy and retention of the data being shared</b></p> <p>Data held and shared is highly likely to be accurate as data shared will normally pertain to recent, live cases. Each organisation will remain responsible for the accuracy of data shared by them, and for informing the other organisation of any changes.</p> <p>Data will be stored by each organisation in accordance with their data retention policies.</p>
<b>12</b>	<p><b>Breach management</b></p> <p>Each organisation will comply with their own policies for breach management. Where a breach occurs in conjunction with data sharing between the organisations, that organisation must inform the other immediately upon discovery (within 24 hours).</p>
<b>13</b>	<p><b>Specify any particular obligation on <u>any</u> party to this agreement</b></p> <p>Each party undertakes to protect personal data supplied by the other organisation as least as well as it protects its own personal data. Liability for breaches will reside with the organisation whose actions/inactions led to the breach.</p>

<p><b>15</b></p>	<p><b>Commencement of agreement</b></p> <p>01 May 2023</p>
<p><b>16</b></p>	<p><b>Review of agreement</b></p> <p>The agreement will be reviewed annually by both parties, or in the event of a significant complaint or breach of shared data.</p>
<p><b>17</b></p>	<p><b>Variation</b></p> <p>Neither party may vary the terms of this agreement except by modification of the agreement itself. Modification must be sought in writing from the other party.</p>
<p><b>18</b></p>	<p><b>Ending the agreement</b></p> <p>The obligations of this data sharing agreement will continue to apply past the end date of any other agreement between the parties, until such time as all personal data covered by this data sharing agreement has been deleted by the party which received it from the other.</p>
<p><b>19</b></p>	<p><b>End date</b></p> <p>Not applicable. See #18.</p>
<p><b>20</b></p>	<p><b>Jurisdiction</b></p> <p>This Contract shall be governed by and construed in accordance with the laws of England and Wales, and the Netherlands.</p>
