Indicative syllabus	The module explores biblical frameworks of leadership, with particular emphasis on the transformational servant leadership model exemplified in the NT material. A range of leadership issues are covered, such as team building, managing change, handling conflict, emotionally intelligent leadership, self-understanding and the development of critical evaluation of practice in a variety of leadership contexts.
